Tuition Registration Drop-in Care Late Fees

**Tuition:** 6 weeks to 18 months: \$225 per week; 18 months to 2 years: \$200 per week; 3 years to 5 years: \$185 per week; After school Care: \$125 per week; Summer Program: \$175 per week or \$50 per day (if spot is available)

**Drop-in:** No reserved space. Please call ahead of time to schedule. **Infant Rate:** \$60.00 per day **All others** \$50.00 per day.

Tuition for all children is due and payable on every Monday before NOON. The child will not be allowed into the daycare the following Monday without all tuition being current. Tuition will be the same whether the child is in attendance one day or all five days for the week. There will be no exceptions. This includes holidays. A \$10.00 late fee is due by Tuesday morning, if payment has not been received by Monday at noon. If tuition is not paid, your child will not be able to remain in care.

Please write your child's name on your money order or check. If paying by cash, please have exact payment amount.

**Returned Check Charge**: \$35.00 All checks not cleared within one week will be turned over to the County Attorney's office for collection.

**Registration:** There is a non-refundable \$100.00 registration fee per child. It must be paid in full prior to enrollment.

**Late Pick-ups**: There is a \$10.00 charge for the first 15 minutes after regular daycare hours (per child). After that, it is \$1.00 per minute per child.

Late fees are to be paid promptly to the staff on duty.

## **Enrollment Agreement**

The parents/guardians whose names appear on the first page of this Agreement hereby agree to permit Busy B's Child Care to administer first aid and/or obtain medical treatment for the child whose name appears on the first page of this Agreement in the event of any injury to the child. The parents/guardians whose names appear on the first page of this Agreement also agree to pay all expenses incurred for such first aid and/or medical treatment and to indemnify Busy B's Child Care and hold Busy B's Child Care harmless against any liability arising from or related to such first aid and/or medical treatment. Busy B's Child Care may terminate this Agreement at any time upon written notice. Busy B's Child Care does not discriminate on the basis of race, color, national origin, cultural heritage, sex, marital status, disability, religion, political belief, or sexual orientation. The parents/guardians whose names appear on the first page of this Agreement acknowledge and understand that Busy B's Child Care MUST receive proper authorization IN WRITING to release a child to individuals NOT listed on the first page of this Agreement. The parents/guardians whose names appear on the first page of this Agreement acknowledge and agree that they shall be liable for any and all costs incurred by Busy B's Child Care arising from or relating to the collection of Tuition, Late Fees and/or Service Charges which are not paid as specified in this Agreement, including any and all attorney's fees and court costs. Busy B's Child Care also has the right to collect interest, charged at the legal rate, for all outstanding balances. Periodically, Busy B's Child Care may institute increases in Tuition and/or other fees. Such increases shall not affect the other terms contained in this Agreement. All other terms shall remain in full force and effect. All parents/guardians agree that should their child(ren) be the subject of an executed, court approved custody, separation or other form of legally enforceable agreement determining the custodial status of such child(ren), they shall provide copies of all such agreements to Busy B's Child Care and shall provide to Busy B's Child Care any and all changes, amendments and updates to such agreements in a timely manner. From time to time, we may provide additional Optional Services from an outside vendor. (i.e. dance, gym, art classes, etc.) If you choose to have your child participate, you will be responsible for any additional cost, which will be paid directly to the vendor. Care provided at Busy B's Child Care meets or exceeds state and local child care requirements. You may periodically receive reports about your child's growth and development in relation to the services provided.
